

UMB Institute for Clinical & Translational Research (ICTR) Community Engaged Research (CEnR) Partnership Development Voucher Award

Applications Accepted Quarterly (February 3rd, May 1st,
August 1st, November 3rd, 2025)

- Eligibility:** Faculty at the level of Assistant Professor, Associate Professor, or Professor with a minimum 51% FTE appointment from University of Maryland, Baltimore (UMB), University of Maryland, Baltimore County (UMBC), or University of Maryland, College Park (UMCP). **New: UMBC and UMCP applications are encouraged to name a UMB Co-PI.**
- Budget:** Up to \$10,000 in Direct costs for 18 months. Funding is through the ICTR CEnR Voucher Mechanism. Applicants are notified of the award decision approximately 6-8 weeks after the application deadline.

I. DESCRIPTION

This ICTR CEnR Voucher Award is specifically for developing a successful and sustainable community partnership(s) in the Maryland and/or District of Columbia (DC) area. The purpose of this award is to prepare for a **future**, competitive ICTR CEnR pilot grant proposal or other extramural CEnR-type pilot grant applications. **Please note that CEnR Partnership Development Award funds CANNOT be used for the purpose of conducting research with a population(s) of interest.**

Typically, CEnR-type pilot grant applications are expected to have an existing community partnership in place that has worked together to identify a population of interest and a research question. This CEnR Voucher award is specifically for that purpose. Activities supported by this CEnR Voucher award include the following:

- Developing a community-academic research partnership(s) infrastructure (e.g., advisory boards, partnership roles and responsibilities, policies and procedures, memorandums of understanding). Eligible community partners include non-profits such as community service organizations, advocacy groups, neighborhood associations, faith-based organizations, or coalitions, public agencies, and private organizations within the State of Maryland and District of Columbia.
- Facilitating formal and informal meetings for partners to identify shared goals, priorities,

research interests, and sharing of resources and funding.

- Facilitating open dialogue and bidirectional learning around challenges and opportunities to address community health needs.
- Identify community partner(s) to engage the community to help define the research question.
- Building research capacity for community partners (e.g., Institutional Review Board training to be a member of the panel, training on research design and methods, etc.)
- Building CEnR capacity for academic partners (e.g., principles of community engagement, 10-Step Framework, etc.)
- Identifying the needs of traditionally underserved or marginalized/minoritized populations.

II. REQUIRED DOCUMENTS

- **Abstract** (use [template](#) found on ICTR website)
- **Budget and Budget Justification** (use [template](#) found on ICTR website)
- **Statement (1 page)** on:
 1. Proposed community partner(s) and approach to develop partnership(s)
 2. For UMBC and UMCP applicants, if you are including a UMB Co-PI, describe the UMB Co-PI's role in developing the community partnership
 3. For UMCP applicants only: 50% of the total CEnR award must be covered by the college and/or department of the applicant. The remaining 50% will be covered by the UMCP Office of the Vice President for Research (VPR). Signatures that document and capture the college and/or department commitment must be secured prior to the submission of the application via the **UMCP Universal Funding form (UFF)** (use [template](#) found on ICTR website). Upload signed document in the CEnR Voucher electronic application. Leave the VPR contribution blank. The VPR office will sign off when an application has been reviewed and selected for funding.  4. Plans for future, intra- and extramural CEnR-type pilot grant funding opportunities.
 5. The impact the CEnR Partnership Development award will have on developing and sustaining community partnership(s) and the health needs of the community.
- **Timeline** (use [template](#) found on ICTR website). Project must be completed with 18 months. No-Cost-Extension is NOT allowed.

III. BUDGET RESTRICTIONS

- **Salary Support:** Salary support may be included for faculty-level members and research staff (no more than 30% of the budget in total).
- **Travel:** Up to \$1,000 may be used for travel with justification to establish a community partnership. Travel is restricted to Maryland and strict of Columbia (DC) area. CEnR funds **cannot** be used for travel to present results at established meetings or conferences.

- **Other Allowable Expenses:** Stipends, supplies, facility use fees, activity costs such as training for community partners, and other expenses required to develop the partnership.
- **Unallowable Expenses:** Tuition, refreshments, purchase of office or laboratory furniture, phone services, and professional membership fees.

IV. REVIEW

Applications will be peer-reviewed, evaluated, and scored using the following criteria:

- **Relevance to CEnR:** Are there clear plans to establish an academic-community partnership to help move a project through to the next step of a future, CEnR-type pilot grant submission?
- **Potential for future community and scientific impact, novelty, and merit.**
- **Feasibility of establishing a sustainable community partnership within 18 months.**
- **Diversity, Equity, and Inclusion:** Could the proposed community partnership benefit traditionally underserved or marginalized/minoritized populations in the future?
- **Future extramural funding plans to further expand the community-partnership and CEnR endeavors.**

V. ADDITIONAL RESTRICTIONS FOR ICTR VOUCHER AWARD

- Cannot be requested to offset expenses in a grant application.
- The voucher award must be exhausted within 18 months of the award date. After 18 months, the remaining voucher award balance will be returned to the ICTR.
- Cannot be encumbered for future use or transferred to another project, researcher, or expense.
- Limited to one voucher award per faculty per 18 months.
- Limited to one voucher award per project.
- The Lead PI of the project must complete the application and not a surrogate/proxy.
